



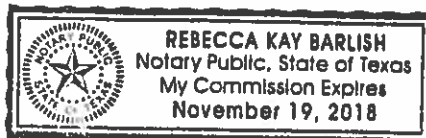

Dixon broke up a fourth-down, fourth-quarter pass in the end zone.

For Henderson, Van Zandt, a TCU commit, finished with 255 yards on 18 carries with touchdowns of 89, 43, 36 and 12 yards. Trestan Ebner hauled in eight passes for 108 yards, giving the fellow Horned Frog pledge a 1,000-plus yard year in receiving yards.

After a 3-for-3 start on third down, the Lions finished 5-for-11 on third-down conversions. Carthage, meanwhile, finished with a 10-for-14 mark. Quickly once again, Van Zandt was in the end zone on a 43-yard score. Carthage 27, Stafford 26

For sheer excitement and downright suspense, Friday's Class 4A, DI regional final between the Carthage Bulldogs and Stafford Spartans at Abe Martin Stadium filled the bill.

Stafford's Kirk Bonilla had his 40-yard field goal attempt blocked shortly after going airborne, and Carthage held on for an electrifying 27-26 verdict, advancing to the Class 4A state semifinals to face the winner of today's China Spring vs. Waco La Vega contest.

The Bulldogs (11-2) rallied from a 28-14 halftime deficit and took the lead late when Kason Davis pegged Dewaylon Ingram on a 5-yard slant with 2:26 left to play. Carthage had taken possession when Jose DeJulian pounced on a Stafford fumble by quarterback Walter White at 6:27 of the fourth quarter.

This set in motion the goal drive for the Bulldogs as Davis tagged Keaontay Ingram for 11 yards and followed with a 27-yard dart to Mekhi Colbert on fourth and six with 4:54 on the clock.

Ingram, who led the Bulldogs with 107 yards on

lison gobbled up a Keaontay Ingram fumble at the conclusion of a five-yard run. Allison was ever-the-opportunist and set the Spartans up in prime real estate at the Carthage 45.

Five plays later it was James Brown skipping in around left end from six yards out at 5:14 of the first. The Brown score was set up when White paired with Jalen Curry on a beautiful 19-yard fade.

The Spartans made it 13-0 early on in the second quarter when Cameron Montgomery proved slippery as he zigged and zagged 42 yards with a Davis punt.

With not even two minutes elapsed in the second period, the Spartans had a surprising 13-0 lead. The Bulldogs had three possessions with two ending in punts and the other in a turnover.

Ingram converted a third down with a six-yard dash and followed with a 10-yard reception from Davis. Carthage finally found the pay window when Davis swung a pass in the flats to Colbert, who broke a tackle at the 25 and raced a total of 32 yards for a TD at 8:05 of the half.

Colbert wasn't quite finished as he helped Carthage forge its first lead of the half when he stripped a ball from the grasp of Hezekiah Jones and lumbered 25 yards for his second score of the evening. Davis slipped across on the 2-point conversion to give the Bulldogs a 14-13 lead with 3:20 remaining.

Stafford closed the first half with a flurry as Montgomery made a spectacular 50-yard dash and the Spartans parlayed a blocked punt into a short scoring drive in the waning moments.

If Saturday's semi-final contest comes close to matching the Bulldogs' other playoff game, it should be a classic.
