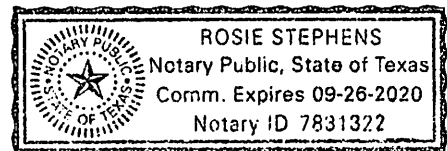

Goodloe led all scorers with 16 points and grabbed a remarkable 24 rebounds. Ashlan Smith, Cedar Creek's 6-2 post, played in her first game since spraining her ankle and managed three points.

Bastrop chose often to shoot 3-pointers but connected on only 5 of 25. The Bears also converted only 4 of 15 free throws.

"We made very poor decisions offensively," Henry said. "At halftime, I told the girls we need to be smarter with our shots and attack the rim. We still continued to jack up threes."

Bastrop's Kya Tarver scored 11 points on 4-of-16 shooting. She was the only Bear in double figures.

Henry would like to see Tarver take advantage of her jumping ability inside more.

"That's something we gotta continue to work on in practice, getting her more comfortable inside," he said. "Even when she did post up, she faded away. I'd like her to turn and attack."

Cedar Creek played without point guard Jayla Gaines, who tore her ACL and is lost for the remainder of the season. Deshelle Welcome stepped into the point guard

position and was primarily responsible for breaking Bastrop's full court press.

Bastrop post Carley Soules also missed the contest after suffering a broken nose in practice. Henry said she will return wearing a mask.

Bastrop played host to Georgetown on Tuesday, while Cedar Creek was on the road against Georgetown East View.
